## General Terms and Conditions

The registration to the 2n Congress of the European Group – International Society for Apheresis (E-ISFA 2018) is solely possible via the online registration form.

The successful online registration implies a binding contract between the conference agency K.I.T. Group GmbH Dresden and the delegate. K.I.T. Group is authorized to act on behalf of the European Group – International Society for Apheresis (E-ISFA) and of the Austrian Apheresis Association (AAA). The delegate receives an official confirmation of registration and invoice for his bookings and has to pay all conference fees in due time as stated on the invoice.

The registration fees are collected by the K.I.T. Group GmbH Dresden on behalf of the Austrian Apheresis Association without Austrian VAT.

The payment can either be conducted by means of bank transfer or by credit card. When conducting a bank transfer any potential bank fees have to be covered by the participant. **Please note:** When registering for the early fee, the payment must be conducted **until February 20, 2018**. Otherwise the normal fee automatically applies for the registration.

The conference fee must be paid fully prior to the conference. Please note that cheques are not accepted.

### Cancellation of registration

For all cancellations received until **February 20, 2018**, the paid registration fees will be refunded minus a cancellation fee of 50 % of the bookings. After this date, no refunds will be made for any cancellations, and accordingly the demand for full payment of the registration fees remains. Any changes of the registration and all cancellations must be communicated to the K.I.T. Group GmbH Dresden in writing only.

### Social Program

A booking of the Gala dinner on March 23, 2018 is binding and the full payment prior to the conference is mandatory. A cancellation until **January 20, 2018** is possible without handling charge. No refund will be made for
